GigaBeam maintains electronic project plans and network designs. Qualified bidders will be provided a login to access read only capacity of the detailed design of the proposed project. Contractor(s) will be provided with a more permanent link to those files upon winning the project.

#### H. Awarded construction projects to commence post award notification.

GigaBeam is not obliged to accept proposals received after the date and time stated above.

Exceptions, if any, will be considered in the proposal evaluation in determining the successful bidder. Bidder must provide supporting documentation with its proposals for any exceptions.

GigaBeam reserves the right to reject any or all proposals, to waive any and all informalities and/or irregularities in the proposal, to negotiate and/or renegotiate with any vendor the terms of its proposal, and to accept any proposal which in its opinion may be in the best interest of GigaBeam.

This contract will allow for a 30 day transition period after award of contract. Pending Executive Approval, contract will commence as soon as possible thereafter.

Each vendor's proposal shall constitute an offer to sell the goods or services sought by this Request for proposals. The award shall be made by execution of a contract mutually agreed upon by both parties.

# Document 1 BID SPECIFICATIONS

Scope of Work for the Montgomery & Bland Counties Fiber Project

#### **PROJECT OVERVIEW**

This document outlines the scope of work for the construction of fiber optic infrastructure project for GigaBeam in areas of Montgomery & Bland Counties, Virginia. The project involves the installation of fiber cable to provide reliable and efficient Fiber to the Premise (FTTX) services. This is a grant funded project, and the project aims to enhance connectivity, improve network capacity, and meet the growing demands of the area.

The project is a partnership with Appalachian Power Company (APCo). Funding is provided through the Virginia Technology Initiative Program (VATI). This project is predominantly aerial fiber construction. There will be some underground work in certain areas.

This project will be bid in three sections (fiber construction, fiber splicing, fiber drops to the premise (aerial and underground). Bidders can be each section independently or the entire project collectively.

#### 1. PROJECT OBJECTIVES

- 1.1. Install fiber optic cable and associated infrastructure.
- 1.2. Perform splicing of fiber optic cable.
- 1.3. Perform customer drops from terminal to NID on Premises.
- 1.4. Ensure adherence to industry standards, testing, regulations, and safety protocols.
- 1.5. Complete the project within the specified timeline.

#### 2. PROJECT DELIVERABLES

- 2.1. Complete installation and termination of fiber optic cable.
- 2.2. Establish connectivity and ensure proper functioning of the network.
- 2.3. Provide accurate as-built documentation, including cable routes, termination points, and equipment locations.
- 2.4. Conduct thorough testing and quality assurance to verify network performance.
- 2.5. Deliver all required project documentation, including monthly project reporting and labor reporting as required by Funding Agency, Grant, GigaBeam, and/or the Regional Commission.

#### Project Tasks (Pre-Construction)

- 2.6. Develop, in coordination with GigaBeam, a detailed project plan, including timelines, milestones, and resource requirements.
- 2.7. GigaBeam will acquire a blanket permit with VDOT for the service drops. It is the responsibility of the contractor to obtain VDOT permits for road crossings, traffic control, etc.
- 2.8. Contractor must have valid VDOT Certifications or qualified 3<sup>rd</sup> party traffic control when applicable.
- 2.9. Responsible for traffic control and traffic control permitting.
- 2.10. GigaBeam is responsible for acquiring railroad permits or building permits. An engineering firm has been

hired to specifically obtain railroad permits.

- 2.11. GigaBeam is responsible for Make Ready and Pole Attachment Agreements. Make Ready is currently being conducted.
- 2.12. Coordinate with GigaBeam and other stakeholders regarding project objectives and expectations.

### Project Tasks (Construction Phase)

- 2.13. Install fiber optic cables, according to industry best practices.
- 2.14. Terminate and splice cables at designated points, ensuring proper connections and minimal signal loss.
- 2.15. Conduct testing to verify network connectivity, signal strength, and data transmission.
- 2.16. Install necessary equipment, such as terminals, anchors, slack loops, sno-shoes, etc. <u>The installation of all rock anchors will be with prior approval of GigaBeam on an as needed basis.</u>
- 2.17. Coordinate with GigaBeam staff with regular progress updates and identified issues associated with the construction process.
- 2.18. GigaBeam will provide all construction materials associated with the construction of the network (fiber, anchors, sno-shoes, etc.) Contractor will be responsible for any specific items needed outside of the construction process that will not be part of the permanent network.
- 2.19. Document all construction work sites before and after construction. This includes pictures and video of every work site. This is to protect the contractor and GigaBeam from inaccurate reports of property damage.
- 2.20. Weekly update calls with detailed information on project status.
- 2.21. Regular reporting and invoicing. This project is grant funded and requires regular detailed reports regarding construction progress as well as labor. Invoicing will also need to follow a standard timeline.

#### Project Tasks (Post-construction)

- 2.22. Provide as-built documentation detailing cable routes, termination points, and equipment locations.
- 2.23. Conduct final testing and quality assurance to ensure compliance with project specifications.
- 2.24. Assist with the resolution of any post-construction issues or deficiencies.
- 2.25. Assist with any post-construction reporting.

#### 3. PROJECT MANAGEMENT

- 3.1. Assign a dedicated project manager responsible for overseeing the entire project.
- 3.2. Regularly communicate progress, milestones, and challenges to GigaBeam's designated representative.
- 3.3. Coordinate with subcontractors, and relevant stakeholders to ensure efficient project execution.
- 3.4. Monitor project costs, timelines, and quality to stay within the allocated budget and schedule.
- 3.5. Implement effective risk management strategies to address any potential project risks or issues.

#### 4. HEALTH, SAFETY, ENVIRONMENTAL

- 4.1. Adhere to all applicable health, safety, and environmental regulations and industry standards.
- 4.2. Implement proper safety protocols and provide personal protective equipment (PPE) for all workers.
- 4.3. Minimize disruptions to the local community and traffic flow during construction activities.
- 4.4. Dispose of construction waste and hazardous materials in accordance with legal requirements.

#### 5. FUNDING AND LABOR REQUIREMENTS

- 5.1. This project is funded through federal and/or state grants. Thus, there are certain requirements that must be met as well as reporting requirements.
- 5.2. This is NOT a Davis Bacon project and there are no Prevailing Wage requirements. However, the contractor must report collective employment wages. Form will be provided.
- 5.3. GigaBeam will hold a 5% retainer until final inspection and acceptance of the project.

#### 6. ADDITIONAL REQUIREMENTS

- 6.1. Each Bidder shall also attach to their proposal statements and/or information relative to the numbered criteria below. Each statement shall be a separate exhibit.
- 6.2. Bidders shall provide unit pricing.
- 6.3. Provide a description of CONTRACTOR's ownership, legal form of organization, state of incorporation or organization, experience, manpower, and principal service area. The statement should describe the experience and technical competence of Bidder and its key personnel (managers and supervisors) who will be involved in this work. Please include copies of resumes for key personnel and identify their prospective role in fulfilling this requirement.
- 6.4. Furnish a Commonwealth of Virginia CONTRACTOR's License as required by the Code of Virginia, certifying that the CONTRACTOR is a licensed CONTRACTOR. List the expiration date, classification and monetary limit under which the work will be performed.
- 6.5. CONTRACTOR has agreed to comply with the labor provisions of all applicable laws of the state in which work is performed, including the Code of Virginia and/or West Virginia Code.
- 6.6. Furnish and maintain all necessary tools and equipment in good working order to provide a safe work environment at all times in compliance with all governing safety organizations.
- 6.7. Furnish evidence of all applicable insurance pursuant to the scope and magnitude.
- 6.8. Furnish a statement regarding the company's written safety policy and associated work procedures. Include with this the frequency of your safety meetings, whether or not you have a full time employee dedicated to employee safety (i.e., Safety Director) and describe your policy with regard to attendance at safety meetings (i.e. mandatory or voluntary participation).
- 6.9. Indicate whether or not your crew members are trained in current first aid practices and CPR in accordance with OSHA standards and state how often you "retrain" your employees in these skills.
- 6.10. Furnish a statement regarding your company's Drug Free Workplace Program.
- 6.11. Furnish a statement regarding your company's knowledge, training, and compliance with OSHA safety protocols. qualified journeyman lineman, as per OSHA requirements.
- 6.12. Provide a representative listing of at least five (5) companies for which the CONTRACTOR has done a substantial amount of line construction work. Please include the name, title, and phone number of the individual at each utility directly responsible for contract line construction, and the dates during which the CONTRACTOR has worked for each utility.

- 6.13. Identify all claims asserted against Bidder's firm or its employees during the past five years alleging that Bidder has breached any contract obligation or has failed to perform satisfactorily any contract obligation.
- 6.14. Bidder must express its agreement to all terms of the Contract on the **BID RESPONSE FORMS**, **Exhibit 1-A**, or describe specific exceptions referenced to specific numbered paragraphs. A failure of a Bidder to accept terms of the Contract deemed material by GigaBeam may disqualify the Bidder.
- 6.15. Before submitting its bid, each Bidder must (a) examine the Contract documents thoroughly, (b) visit the plans on the electronic system to familiarize itself with local conditions that may in any manner affect performance of the work, (c) familiarize itself with federal, state, and local laws, ordinances, rules and regulations affecting performance of the work, and (d) undertake such further inquiries and examinations as the Bidder deems appropriate and desirable to permit it to prepare its bid. Bids by a partnership shall be signed in the name of the partnership by at least one of the general partners of the partnership.
- 6.16. Bidding Pre-Qualification. GigaBeam maintains its network design and construction documents via an online platform. All perspective bidders shall pre-qualify by completing a Non-Disclosure Agreement (ATTACHMENT 2). Email Greg Hedrick at gregh@GigaBeam.net to obtain a copy of the agreement. Upon completion of the agreement, qualified bidders will be given a limited access login to view the various details and design of the project. Once bids are awarded, the winning bidder will be granted their own login access to the platform throughout the project.
- 6.17. Bidding Questions. GigaBeam will provide a time for all bidding questions to be submitted. GigaBeam will provide a list of all questions and responses to all qualifying bidders.
- 6.18. All responding Bidders will be notified after the bid evaluation is complete. GB reserves the right to reject any and all bids, the right to waive any and all informalities, and the right to disregard all nonconforming or conditional bids or counterproposals. GB shall be the sole arbiter of the conformity of bids to this Specification.
- 6.19. Bidders warrant that they will not discriminate against any employee or applicant for employment because of race, color, religion, sex, age, or national origin. CONTRACTOR will not discriminate against any employee or applicant because of disability, so long as an applicant with such disability is qualified for employment. CONTRACTOR will take ensure that applicants are employed, and that employees are treated during employment, without regard to their race, color, religion, sex, age, national origin, or disability.
- 6.20. Final selection will be based on such factors as GigaBeam in its sole discretion deems relevant, including, without limitation, rates, financial stability, a survey of referenced long-term customers of Bidder, and the overall quality of the equipment and organization proposed for this Contract.

#### 7. SCOPE OF WORK

The purpose of this Request for Proposal (RFP) is to solicit proposals from qualified companies seeking to provide construction crew(s) for the new construction of our Fiber Optic Infrastructure Project in portions of Montgomery and Bland Counties, Virginia. This project is in coordination with middle mile fiber being

constructed by APCo in the two localities. GigaBeam fiber being constructed interconnects with leased fiber from APCo.

- 7.1. The contractor must also have the ability to supply crews as needed for overhead construction, as the work dictates.
  - 7.2. The CONTRACTOR shall furnish all necessary and appropriate supervision, labor, equipment, tools, transportation, and other resources to perform construction. This work will be of good quality, free from faults and defects as called for in strict accordance with the Contract and Specifications.
    - Underground construction is not expected, except for those bidding on drops.
  - 7.3. All construction shall comply with GB standards and specifications as put forth. CONTRACTOR's work shall be guaranteed for one (1) calendar year from the start of work on any given circuit.
  - 7.4. All work performed by the CONTRACTOR will be subject to the inspection of GBs Representatives, and payment will be withheld for any work not complying with the prescribed plans and Specifications until deficiencies are corrected. CONTRACTOR shall correct any deficiencies (rework) of a completed circuit within thirty (30) business days upon notification from GIGABEAM or GIGABEAM Project Representative. If after thirty (30) calendar days or upon notification from CONTRACTOR that rework is complete, and GIGABEAM or GIGABEAM Project Representative determines that areas have still not been completed satisfactorily, GIGABEAM may elect to use other resources, including but not limited to competing CONTRACTORS to correct deficiencies and deduct cost from CONTRACTOR's payment and/ or performance bond. GIGABEAM will use past CONTRACTOR performance in evaluating future CONTRACTOR bids.
    - Prior to the beginning of each project, GIGABEAM will furnish the CONTRACTOR access to the online set of project plans.
  - 7.5. In completing the Work hereunder, CONTRACTOR shall comply with all applicable commonly accepted industry regulations and laws, including but not limited to; *OSHA and VDOT*. If any provision of the Specifications conflicts with any of these laws and regulations, the laws and regulations shall prevail.

#### 8. PERSONNEL QUALIFICATIONS AND TRAINING

8.1. CONTRACTOR shall comply with all local, state, and federal regulations and all workers must have sufficient skill and experience to perform properly and safely the work assigned to them. GIGABEAM shall have the right to require removal from responsibility for any work under the Contract, any employee of CONTRACTOR, or any approved subcontractor who, in the opinion of GIGABEAM, does not perform his/her work in a proper, safe, and skillful manner or is disrespectful, intemperate, disorderly, or otherwise objectionable to GIGABEAM.

- 8.2. CONTRACTOR employee safety training and following said training is the responsibility of the CONTRACTOR. Safety violations may also result in disciplinary action up to and including termination.
- 8.3. GIGABEAM expects CONTRACTOR's work force to be fully trained and thoroughly familiar with all aspects of fiber optic utility construction before beginning work on GIGABEAM system. CONTRACTOR shall present GIGABEAM or GIGABEAM's Project Representative with a detailed list of personnel by crew, by name, experience and identify specific training they have received on safety and utility work upon request by GIGABEAM or GIGABEAM's Project Representative. As new personnel or crews are added, CONTRACTOR shall continue to follow these procedures.

#### 9. EQUIPMENT

- 9.1. The CONTRACTOR's equipment shall be kept in neat appearance and in good operating condition at all times and shall comply with applicable local, state, and federal standards and regulations. All vehicles will be equipped with adequate first-aid and safety supplies and traffic control devices that comply with applicable safety standards. CONTRACTOR shall notify GIGABEAM of any inoperable equipment and remove it from the job immediately for repair or replacement. If a significant piece of equipment is, in the judgment of GIGABEAM, chronically inoperable, CONTRACTOR may be required to remove the crew using such equipment.
- 9.2. Equipment shall be removed from service for cleaning, maintenance, or repair, including, without limitation, washing and cleaning of vehicles; fueling of vehicles; oil or antifreeze changes. CONTRACTOR shall routinely check for leaks (oil, gas, antifreeze, etc.) and immediately remove equipment from service for maintenance, or repair, if a leak is discovered, the spill must be cleaned up immediately.

#### 10. WORKER AND VEHICLE IDENTIFICATION

- 10.1. The CONTRACTOR's employees shall always wear clothing, badges, or other apparatus, identifying them as employees of the CONTRACTOR. CONTRACTOR's employees shall identify themselves by name and position at any time requested by the public or a GIGABEAM Representative. GIGABEAM, at its own discretion, may require CONTRACTOR employees to wear identification badges.
- 10.2. Each vehicle shall be marked with CONTRACTOR's insignia, name, and number designating it as property of the CONTRACTOR. GIGABEAM, at its own discretion, may furnish and require the CONTRACTOR to display on their equipment signs identifying them as contracted to GIGABEAM.

#### 11. SAFETY SIGNS AND TRAFFIC CONTROL

11.1. CONTRACTOR shall comply with all applicable laws, regulations, and standards

describing traffic safety and control procedures and shall post appropriate signs, barricades, and flagmen to protect against dangers associated with CONTRACTOR's activities.

#### **12. METHODS OF OPERATION**

- 12.1. CONTRACTOR shall utilize reasonable working hours when working around residences, churches, places of business, etc. CONTRACTOR shall apply to GIGABEAM or GIGABEAM's Project Representative in writing for approval to work outside of normal GIGABEAM working times which are Monday Friday; 8:00am 4:00pm, or on GIGABEAM designated holidays. Holidays observed by GIGABEAM are: New Year's Day, Good Friday, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and the day after Thanksgiving, Christmas Eve, and Christmas Day.
- 12.2. CONTRACTOR shall abide by all local ordinances regarding restrictions on working hours. This particularly includes noise ordinances of respective communities within the GIGABEAM system.
- 12.3. CONTRACTOR shall provide GIGABEAM full information in advance as to its proposed approach to the work. GIGABEAM may require CONTRACTOR to modify its approach to completion of the work, and CONTRACTOR shall promptly comply with such instructions. Neither compliance with such instructions nor failure of GIGABEAM to issue such instructions shall relieve CONTRACTOR from its obligations under the Contract, including, without limitation, its obligations concerning safety, quality of work, and the rate of progress required by GIGABEAM. CONTRACTOR alone shall be responsible for the safety, adequacy, and efficiency of its plant, equipment, and methods.

#### 13. WORK MANAGEMENT AND SUPERVISION

- 13.1. CONTRACTOR shall designate a duly authorized manager, superintendent, supervisor, or foreman who shall be available during all periods of work undertaken by CONTRACTOR. The Supervisor shall be a fully qualified, possessing the necessary certifications and license. The Supervisor shall be fully authorized to act for the CONTRACTOR, to receive whatever instructions may be given by GIGABEAM, and to cause compliance by all of CONTRACTOR's forces with such instructions.
- 13.2. The Supervisor or his/her assistant shall be available by telephone, cellular phone, or a twoway radio during all periods of work undertaken by CONTRACTOR.
- 13.3. The Supervisor shall update the GIGABEAM project representative weekly (minimum) on areas that CONTRACTOR has worked with details on type and amount of work completed such that GIGABEAM may maintain a mapping plan of the construction updates.
- 13.4. The GIGABEAM project representative will direct and schedule all construction areas with the Supervisor.

#### 14. COMMUNICATION

14.1. General Foremen and Supervisor are required to attend an orientation meeting with GIGABEAM and/or GIGABEAM's Project Representative before starting ANY work on the GIGABEAM system. It shall be the responsibility of the General Foremen and/or Supervisor to provide training to all CONTRACTOR crews to ensure work is completed in compliance with GIGABEAM contract specifications.

#### 15. ENVIRONMENTAL COMPLIANCE; PERMITS

- 15.1 CONTRACTOR shall comply with all applicable local, state, and federal environmental ordinances, laws, and regulations. All work along streams, creeks, rivers, and wetlands shall be performed in accordance with local, state, and federal regulations and in compliance with Best Management Practices (BMPs). Crossing streams, creeks, rivers and wetlands with vehicles or equipment must be avoided if there is a practical alternative that can be used. The crossing of streams, creeks, rivers, and wetlands is allowable provided all federal, state, and local regulatory requirements are met, all appropriate permits are obtained, and GIGABEAM is notified prior to the crossing. CONTRACTOR is required to repair all disturbances or damage to streams, creeks, rivers, and wetlands using BMPs approved by GIGABEAM.
- 15.2 CONTRACTOR shall not use, store, or dispose of Hazardous Substances on GIGABEAM property, easements, or rights-of-way or on the property of customers.
- 15.3 Waste/ debris shall be transported and disposed of at locations in compliance with applicable ordinances, laws, and regulations.
- 15.4 CONTRACTOR shall be responsible for obtaining, maintaining, and complying with all necessary permits specifically not obtained by GIGABEAM.
- 15.5 GIGABEAM shall be responsible for all major tree trimming, CONTRACTOR shall be responsible for any minor tree trimming. Trimming responsibilities to be determined on an individual project basis between both parties. Clearance will be addressed by the GIGABEAM during project planning meetings.

#### 16. PROPERTY OWNER NOTIFICATION AND CONSENT; EXTENT OF INGRESS and EGRESS

16.1. For ingress and egress easements, CONTRACTOR will contact and explain to property owners the type and extent of work needed on their property or make arrangements for the scope of work. Most of the construction will be in existing power company right of way. However, it will still be the CONTRACTOR's responsibility to coordinate with the property owner for entry into property and to advise the owner(s) of any incomplete work on their property. The CONTRACTOR and his employees shall also be prepared to answer any customer questions as to the reasons for the type or extent of the work or to direct them to the proper person who can respond in a prompt manner.

#### **17. EVALUATIONS AND COMPLETION**

17.1. GIGABEAM or GIGABEAM's Project Representative will evaluate CONTRACTOR performance for each project at the conclusion of the work based on components such as framing/ splicing / anchoring techniques, worksite cleanliness, quantity of work, quality of work, customer relations, and responsiveness to problems and their resolution and effectiveness in completing work without rework.

CONTRACTOR shall be provided with a copy of the evaluation report upon written request. CONTRACTOR performance evaluations shall be utilized concerning future construction management CONTRACTOR bids.

#### 18. CUSTOMER SERVICE/QUALITY CONTROL

- 18.1. CONTRACTOR shall be solely responsible for prevention of damage from work undertaken pursuant to the Contract and for all injury, damage, or loss caused by CONTRACTOR's negligent or willful acts or omissions during performance of the work. All reasonable precautions shall always be taken to protect the work and to protect against injury, damage, or loss arising out of the work. GIGABEAM reserves the right to specify additional actions to prevent injury, damage, or loss arising out of the work.
- 18.2. CONTRACTOR shall, at its own expense, reimburse injured parties for all injury, damage or loss caused by CONTRACTOR's negligent or willful acts or omissions during performance of the work under this Contract.
- 18.3. GIGABEAM or GIGABEAM's Project Representative shall maintain communication with CONTRACTOR General Foreman and/or Supervisor regarding identified agreements with customers regarding deviations of protocol of this contract.
- 18.4. CONTRACTOR must ensure one person of each crew is fluent in English and he/she must be always available and at all worksites to courteously and adequately address any inquiries from the customer regarding construction activities. This designated contact shall be alert and receptive to potential customer communication in addition to any duties so designated on the given crew.
- 18.5. When work needs to be performed in backlots, the crew's customer contact is required to knock on the customer's door and notify them. If the customer is not at home, the crew may proceed with the work, however, trucks and other heavy equipment shall not be taken onto customer's properties without permission. CONTRACTOR shall utilize the right-of-way to gain access to all properties where practical. Any other access to the right-of-way shall be arranged between CONTRACTOR and respective property owner, including railroad and Virginia Department of Transportation (VDOT) access. All fences must be maintained during the course of the work and all gates will be left as found (open/closed) while gaining access to the right-of-way.
- 18.6. Documentation with pictures and video is essential for all worksites and whenever crews enter or leave a premise. This evidence protects the CONTRACTOR and GIGABEAM.
- 18.7. Equipment, components, and debris shall be handled in such a manner as to avoid obstructing roads, paths or waterways, except as may be required, as defined by GIGABEAM or GIGABEAM's Project Representative. All worksites shall be cleared daily and left free of equipment, components, debris, and litter, except as may be required, as defined by GIGABEAM or GIGABEAM's Project Representative. It shall be the financial and physical responsibility of CONTRACTOR to daily dispose of all components resulting from activities and removal process. If for reasons beyond the control of CONTRACTOR, they find they are unable to remove components, debris, and litter from customer(s) premises that day, CONTRACTOR shall request approval from GIGABEAM or GIGABEAM's Project Representative to remove such components at a later date and notify customer(s), providing a date of when the worksite will be cleared. If customer(s) is unavailable for such notification, CONTRACTOR shall notify GIGABEAM and/or

GIGABEAM's Project Representative.

- 18.8. CONTRACTOR shall use extreme care when cutting brush or trees that are close to or touching power wires and shall prevent breaking the wire or slapping two wires together or in any other way disrupting service. If any damage to wires or interruption to service occurs, CONTRACTOR shall notify GIGABEAM Operations Dispatcher or GIGABEAM Project Representative immediately. If GIGABEAM determines that the damage is the result of CONTRACTOR negligence, CONTRACTOR shall pay to repair the damage and all other losses associated with CONTRACTOR's actions including lost revenue if requested by GIGABEAM. If other utility wires (i.e., telephone, cable television, etc.) are damaged or service disrupted due to CONTRACTOR activity within the right-of-way, CONTRACTOR is responsible for contacting the affected utility and restoring service to the customer.
- 18.9. CONTRACTOR shall prevent damages to customer's properties by following proper procedures, including, but not limited to, the use of ropes when necessary to prevent components from falling and damaging service drops, landscaping, fences, outbuildings, and other property, including lawns. If property damage occurs, CONTRACTOR shall notify GIGABEAM or GIGABEAM's Project Representative and customer(s) and provide a date for repairing the damage. If customer(s) is not available for notification, CONTRACTOR shall notify GIGABEAM or GIGABEAM's Project Representative to leave door hanger with precise date for repair of damages. CONTRACTOR is responsible for all property damage liability incurred during the work indemnifying and holding harmless GIGABEAM and/or GIGABEAM's employees and/or representatives. CONTRACTOR shall provide a copy of a written release form from affected customer ensuring repairs to damages have been properly rectified upon GIGABEAM request.
- 18.10. GIGABEAM reserves the right to remove ANY/ALL CONTRACTOR employees that, in the sole opinion of GIGABEAM, may do harm to GIGABEAM-Customer positive relations. GIGABEAM expects CONTRACTOR to perform due diligence in regard to positive customer relations.

#### **19. PAYMENT & PERFORMANCE BOND REQUIREMENTS**

19.1. CONTRACTOR shall provide a performance bond in the amount of the bid price plus ten percent (10%) for awarded contracts that exceed ten thousand dollars (\$10,000) to GIGABEAM before the work shall commence. Awarded contracts of less than ten thousand dollars (\$10,000) shall not require a performance bond. CONTRACTOR(S) awarded multiple projects shall provide individual performance bonds for each awarded project. Each performance bond shall be in force until the satisfactory completion and/or until the term end of Contract period of contracted work.

#### 20. BILLING AND PAYMENT REQUIREMENTS

- 20.1. Payment for work performed shall be billed and submitted monthly by CONTRACTOR. CONTRACTOR(S) awarded multiple projects shall submit itemized billings for each project.
- 20.2. CONTRACTOR shall invoice GIGABEAM for itemized work performed in full, according to above.

# DOCUMENT 1-1 GIGABEAM PROJECT CONTRACT

GigaBeam Networks LLC, party of the first part, hereinafter called "GIGABEAM" and, having its principal offices at <u>387 Old Virginia Ave., Rich Creek, Virginia, 24147</u>, and registered to do business in the Commonwealth of Virginia; and \_\_\_\_\_\_, party of the second part, hereinafter called "CONTRACTOR".

Witness, that for and in consideration of the covenants and agreements hereinafter mentioned, to be performed by the parties hereto, and the payment hereinafter agreed to be made, it is mutually agreed as follows:

- CONTRACTOR agrees to furnish all supervision, labor, tools, transportation, equipment, and materials necessary to perform construction work on GIGABEAM's transmission and distribution infrastructure, specifically (Fiber Construction, Splicing, and/or Drop Installations) (Circle the appropriate work). Construction to include the installation of the appropriate equipment, cabling, and services as required within the GIGABEAM service territory, and to dispose of the debris resulting from such work, as directed by GIGABEAM, and in accordance with the bid specification (Document 1).
  - 1.1. Material will be supplied by GIGABEAM and picked-up/ transported by CONTRACTOR as needed from the GIGABEAM storage facilities in Montgomery County (transportation costs assumed by CONTRACTOR).
- 2. CONTRACTOR agrees to secure all permits and licenses of a temporary nature necessary for the prosecution of the work to be performed hereinafter and to pay all charges and fees required for such permits and licenses. GIGABEAM will cooperate with CONTRACTOR in such permitting.
  - 2.1. CONTRACTOR agrees to obtain consent or permission for the necessary work from the property owner or public authorities having ownership or control over each property requiring ingress and egress. If permission to do any work cannot be obtained, such work shall not be done, and all such omissions shall be reported to GIGABEAM. No further action shall be taken in such cases except upon the mutual agreement of the parties hereto. GIGABEAM will cooperate with CONTRACTOR in such permission to remedy the situation.
- 3. CONTRACTOR agrees to perform all work to the complete satisfaction of GIGABEAM and in accordance with all municipal, county, state and other local laws, ordinances, and regulations applicable to said work. All work shall be performed in accordance with standards outlined in Document 1 for such work.
- 4. CONTRACTOR agrees that its personnel and equipment shall meet requirements of Document 1, and all work shall be done, and all complaints handled by CONTRACTOR with due regard for GIGABEAM's public relations.

- 5. CONTRACTOR agrees that complaints of any nature received from property owners or public authorities shall receive immediate attention and that all efforts shall be made to effect a prompt adjustment. All complaints, and any action taken by CONTRACTOR in connection with such complaints, shall be reported to GIGABEAM.
  - 5.1. It is understood that CONTRACTOR does not represent GIGABEAM and has no authority to obligate GIGABEAM for any payment or benefit of any kind to any person.
  - 6. CONTRACTOR agrees to abide by all laws pertaining to traffic control by keeping the necessary guards and protective devices at locations where work is being performed to prevent accidents or damage to the property of GIGABEAM or the public.
  - 7. CONTRACTOR agrees to abide by the unit pricing that is provided to GIGABEAM through its bid for work associated with this project.
  - 8. CONTRACTOR agrees to indemnify, save harmless, and defend GIGABEAM, and, their agents, officers, servants, employees and insurers from and against any and all liability for loss, damage, or expense which GIGABEAM may suffer or for which GIGABEAM may be held liable by reason of any injury (including death) or damage to any property arising out of negligence on the part of CONTRACTOR or any of its representatives or employees in the execution of the work to be performed thereunder.
  - 9. CONTRACTOR shall maintain throughout the term of this Contract statutory worker's compensation insurance and policies of liability insurance covering the risk assumed in performance of work under this Contract. General liability insurance shall be maintained during the term of this Contract and shall have minimum policy limits of \$1,000,000 for personal injury to or death of any one person, and \$4,000,000 aggregate for any one accident. Vehicle insurances limits shall be \$1,000,000 each occurrence and aggregate \$1,000,000. The general liability and vehicle insurance shall have minimum policy limits at \$1,000,000 for property damage. GIGABEAM shall be listed as an additional insured under all such policies.
  - 10. This agreement shall be binding upon the parties hereto and their heirs, executors, administrators, and assigns.
  - 11. This agreement is not intended to constitute an agreement of hiring under the provisions of any workmen's compensation or unemployment compensation law, and old age benefit law, or any similar law, and it shall not be so construed. CONTRACTOR agrees to accept full and exclusive liability for the payment of contributions or taxes imposed under such laws by the Federal and/or State Government which are measured by remuneration paid to CONTRACTOR'S employees.
  - 12. Should CONTRACTOR fail to carry out the work to the satisfaction of GIGABEAM, or to comply with any of the provisions of this agreement, GIGABEAM may terminate this Contract upon twenty-four (24) hours written notice to CONTRACTOR.
  - 13. The CONTRACTOR shall take whatever legally and morally acceptable precautions necessary to preclude delay of completion of the project due to theft or vandalism of material, equipment, or tools.
  - 14. If construction is adjacent to poles carrying energized circuits, the CONTRACTOR shall instruct his employees as to the dangers and responsibilities involved.
  - 15. No burning will be allowed at any job site.
  - 16. No hazardous materials will be stored at any job site. The CONTRACTOR will be held responsible for all Page **15** of **26**

remediation of spills which occur during each project.

- 17. The CONTRACTOR shall provide a copy of its Safety Plan.
- 18. Construction site safety is the responsibility of the CONTRACTOR.
- 19. The CONTRACTOR shall provide documentation of any job briefings upon GIGABEAM request.
- 20. All apparatus, structures, equipment, and materials to be furnished and their arrangement, erection and installation shall be subject to the approval of GIGABEAM.
- 21. All workmanship and material shall be of high quality and all material shall be free from defects affecting appearance and serviceability of the equipment. The material and design of the structures, apparatus and equipment shall be such as has been proven to be satisfactory for the intended application by experience, and commercial service, and by comprehensive laboratory tests.
- 22. All equipment and materials and their installation shall conform in all respects to the latest revisions of applicable IEEE, ASTM and NEMA standards and in accordance with all applicable rules of the NESC, and local and state ordinances.
- 23. The job Foreman and lead person on a construction crew shall be experienced linemen, who have performed this type of work. GIGABEAM may require proof of such experience prior to start of work.
- 24. The CONTRACTOR shall notify GIGABEAM of any damaged, faulty, or unsafe materials or equipment encountered during the performance of the work.
- 25. CONTRACTOR shall provide GIGABEAM testing results on all equipment, splicing, and fiber installation. GIGABEAM reserves the right to withhold payment for any work performed that does not meet testing and operational requirements.
- 26. CONTRACTOR shall be responsible for underground locating and all 811 Tickets. Digging may not occur until all utilities are located or designated clear.
- 27. CONTRACTOR shall notify GIGABEAM of any required major tree trimming prior to it being performed. Work may be performed by GIGABEAM or performed by a GIGABEAM ROW CONTRACTOR. If tree trimming is in the power space, the proper utility company shall be notified.
- 28. The CONTRACTOR at the request of GIGABEAM shall replace any person from his or her own workforce or their subcontractor's workforce, who in the judgment of GIGABEAM, may be deemed undesirable for the job duties. A request of this nature will be handled by the GIGABEAM Construction Supervisor and the Vice President of Operations. However, GIGABEAM does reserve the right to immediately remove from the site any person felt to be an immediate safety risk.
- 29. Approval in writing shall be attained from GIGABEAM prior to the project assignment, or hiring, of any former GIGABEAM employee.
- 30. Suspension of Work and Termination:
  - 30.1. Upon the occurrence of any of the following events GIGABEAM has the right to terminate this contract in accordance with General Conditions:
  - 30.2. If the CONTRACTOR persistently fails to perform the work in accordance with the contract documents (including, but not limited to, failure to supply skillful workers or suitable tools and

equipment to adhere to response time).

- 30.3. If the CONTRACTOR disregards laws or regulations of any public body having jurisdiction.
- 30.4. If the CONTRACTOR disregards the authority of the GIGABEAM representatives
- 31. Salvage Materials removed from any existing lines shall be delivered to GIGABEAM. Coordination regarding salvage materials shall take place between the CONTRACTOR and GIGABEAM.
- 32. CONTRACTOR shall obtain prior approval from GIGABEAM before utilizing any rock anchors or varying from the designated construction methods or paths.
- 33. CONTRACTOR agrees to assign to each project under the terms of this proposal the proper equipment and competent employees and agrees that the number of such employees and the amount of such equipment assigned to any job shall not be excessive but shall be sufficient to perform the job quickly and efficiently.
